The following is my statement:

Statement of Mark Evans, Etna Township Trustee

On today's date, just before noon, I was involved in a minor traffic accident at Etna Township Hall.

Upon arriving earlier in the morning for a meeting, I parked in a non-routine area. This was due to ongoing concerns about vehicles parking along the Pike Street side of Township Hall, which obstruct clear sight lines for traffic turning onto Pike Street.

When leaving the Township Hall, I exited in a different direction than I had entered. While backing out slowly, I had to proceed until I cleared the large curb on the right side. At that point, due to the bed boxes mounted on my truck, I did not see the nearby stop sign. Traveling at a very low rate of speed, my vehicle made contact with the stop sign post.

I immediately pulled forward and had to complete a multi-point turn because of the elevated curb. Once I observed that the stop sign post was bent, I drove to the Township Road Department to notify the road crew. They were not present, so I contacted the Assistant Road Superintendent, who was at lunch with the crew, and informed him of the damage.

As I am an elected Trustee of Etna Township, the Township itself was immediately made aware of the incident.




