Your email response is noted. However, I must address the seriousness of this matter. This is not the first time you have made comments of a disparaging, untruthful, and offensive nature concerning a sitting member of this Board. While you request that I cease all further emails to you, that is neither reasonable nor appropriate in the context of township administration. Due to your repeated conduct, I will be moving for the Board to enter executive session at our next meeting for the purpose of discussing potential disciplinary or removal actions. This will include a review of both your recent statements and prior behavior that has raised similar concerns.

Professionalism and integrity are not optional in township service. Residents expect and deserve better.

Additionally, I am researching your claim that there was a challenge to the annexation agreement that went through court and was affirmed. Neither your timeline or description appear to be correct.

Your apparent lack of due diligence and confirming such information but presented it as fact is concerning.
